Sub: Financial approval of the project under Women Scientist Scheme A (WOS-A) entitled "Preparation and characterization of ferroelectric-ferrite composites."

Sanction of the President is hereby accorded to the above mentioned project at a total cost of ₹ 26,10,000/- (Rupees Twenty Six Lac Ten Thousand only) with a break up of ₹ 5,00,000/- under 'Capital head' and ₹ 21,10,000/- under 'General head' for a duration of Three years. The interest thus earned will be treated as a credit to the institute to be adjusted towards further installment of the grant.


