Subject: Selection against Notification No.06-PSC (DR-P) of 2023 dated: 01.03.2023 and Notification No.17-PSC (DR-P) of 2023 dated: 15.05.2023 for the post of Assistant Professor Physics in Higher Education Department to the extent of OM category only in supersession to the Provisional Select List issued vide Notification No.29 -PSC(DR-S) of 2024 dated 14.08.2024-
Issuance of revised select List thereof.

Whereas, Higher Education Department vide letter No. HE/COLL/Coord/A.P./2021 Dated 05 -07 -2021 read with No HED-GAZ/85/2022-04 Dated 13-04-2022 referred one post (01) under OM category of Assistant Professor Physics, to J&K Public Service Commission, for selection of candidate.

Whereas, J&K Public Service Commission Vide Notification No 06-PSC (DR-P) of 2023 dated 01-03-2023, invited applications for filling of the above post. The cut-off date for determining the eligibility was 31-03-2023.

Whereas, again, vide letter No HED-GAZ/85/2022-04 dated 24-03-2023 Higher Education Department, referred twenty eight posts(28) of Assistant Professor Physics, to J&K public Service Commission, for selection of candidates ;

Whereas, J&K Public Service Commission vide Notification No. 17-PSC (DR-P) of 2023 Dated 15-05-2023, invited applications for filling of aforementioned 28 posts. The cut-off date for determining the eligibility was 16-06-2023; and,

Whereas, written test was conducted on 05-11-23 and result of the written test was declared vide Notification No. PSC/EXM/S/2024/08 Dated 01-04-2024. Five (05) candidates were shortlisted against Notification No 06-PSC (DR-P) of 2023 dated 01-03-2023, and eighty six (86) candidates were shortlisted against Notification No. 17-PSC (DR-P) of 2023 Dated 15-05-2023. Five (05) candidates were common against both the Notifications as such the interview of 86 candidates only was conducted only; and,

Whereas, viva -vocè of candidates was conducted on 12th and 13th of August, 2024 with the assistance of experts from outside the UT and,

Whereas, J&K Public Service Commission notified the provisional selection list for the post of Assistant Professor Physics vide Notification No 29-PSC(DR-S) of 2024 dated 14-08-2024 and also invited objections, if any, against the Provisional Select list which were to be submitted within five days from the issuance of Provisional Select List; and,

Whereas, 06 representations were received against the provisional Select list, out of which 05 representations were disposed off vide Notice dated 01.10.2024. However, the representation received against one of the provisionally selected candidates and pertaining to the crediting of score for research publication(s) was examined and referred to the experts for opinion.

Whereas, recommendation in respect of the 28 selected candidates was forwarded to the Higher Education Department vide letter No.PSC/DR/HE-AP Physics/2023 Dated: 01.10.2024, and selection against one post under OM category against Notification No.17-PSC (DR-P) of 2023 was kept withheld on account of the aforementioned reason.

Whereas, based on the opinion of the experts dated 18.10.2024 & 20.10.2024 received in the first instance by the Commission, the credit score of the aforementioned provisionally selected candidate entailed change and consequently his credit score got refixed at 56.27 instead of the earlier score of 57.27.

Whereas, aforementioned candidate filed a counter representation against two other candidates before the Commission challenging the marks awarded to them for Research publications /Experience and SET/NET/JRF ; and,


Whereas, it was deemed appropriate that there is a need for proper screening of the already framed Select List and the matter was placed before the Commission and the Commission in its meeting held on 08.11.2024 decided to constitute a committee for a holistic review of the Select List; and

Whereas, in pursuance to the decision of the Commission, a committee comprising of Deputy Secretary & Under Secretary of J&K Public Service Commission was constituted vide Order No. 174-JKPSC of 2024 Dated 08.11.2024 for examining the already framed select list .

Whereas, in the backdrop of counter representation the opinion of the experts was again sought and the same was received on 27.11.2024.

Whereas, the committee constituted for the purpose furnished the factual report on 05.12.2024 and recommended reconfiguration/recast of the provisional Select list, notified vide Notification No. 29-PSC (DR-S) of 2024 Dated 14.08.2024 to the extent of OM category candidates only in the purview of reevaluation of Academic merit, Special Attributes-(research & publications)& experience .

Whereas, in view of thereport of the Committee read with the opinion of the subject experts, the provisional select list to the extent of candidates under OM category only and reflecting the provisional selection of other category candidates notified vide Notification No. 29-PSC (DR-S) of 2024 Dated 14.08.2024 is re-configured/recast with respect to OM category only as under:



Whereas, in the revised select list as above, Mr Mashkooor Ahmad Dar, (Score: 61.38) figures in the Select list against Notification No.06-PSC of 2023 instead of the earlier listed candidate, namely, Mr Abdul Wakeel who now figures at S.No. 01 against the Notification No.17-PSC of 2023, since in respect of Mr Abdul Wakeel, the Gazette Notification pertaining to his Ph.D eligibility bears the date of 15.06.2023 as such his candidature stands considered against Notification No. 17-PSC(DR-P) of 2023 instead of Notification No. 06-PSC(DR-P) of 2023. For Notification No. 06-PSC(DR-P) of 2023 the cut-off date is 31.03.2023.

Whereas, the reconfiguration/recast of the Select list is spread over the following candidates under Open Merit Category, resulting in inclusion in the select list, of candidate namely Binti Sharma (56.33) being higher in merit than the excluded candidate namely Ajaz Ahmad Mir (56.15) and in comparison with the last selected candidate under Open merit category namely Abdul Matten Tantray (56.27)
